Enclosed for filing pursuant to the Interstate Commerce Act and the Commission's regulations is the following tariff issued by Enbridge Pipelines (North Dakota) LLC ("Enbridge North Dakota") with an issue date of July 14, 2006 and an effective date of August 14, 2006, on 30 day's notice:

Explanation of Tariff Filing

Pursuant to 18 C.F.R. § 341.5, Enbridge North Dakota hereby files Supplement No. 1 to FERC No. 39, which cancels FERC No. 39. This tariff is being cancelled because Enbridge North Dakota can no longer offer service for the applicable route, as the pipeline has been taken out of service.

For alternative rate and routing between the origin and destination listed in the cancelled tariff, refer to Enbridge Pipelines (Westpur) Inc. NEB Tariff No. 42, Enbridge Pipelines Inc. NEB No. 274, and Enbridge Energy, Limited Partnership FERC No. 25. Together, these systems provide the following alternative route:

For movements originating on gathering systems in Saskatchewan, shippers can arrange to move crude petroleum on the Enbridge Pipelines (Westpur) Inc. system to Cromer, Manitoba (NEB 42). From Cromer, Manitoba shippers can move on the Enbridge Pipelines Inc. system to the International Boundary near Gretna, Manitoba (NEB 274). Once at the border, movements can elect to move on the Enbridge Energy, Limited Partnership system from the International Boundary near Neche, North Dakota to Clearbrook, Minnesota (FERC 25).
